- In accordance with the Issuer's policies, a restricted stock grant to Mr. Bushnell having, at the time of grant, an aggregate fair market value of \$100,000, was made on August 4, 2008, the third business day following the release date of the Issuer's financial results for the second (1) fiscal quarter of 2008. The price per share at the close of business on August 4, 2008 was \$50.46. The restricted stock will vest ratably over a three-year period commencing on the anniversary date of Mr. Bushnell's election to the Issuer's Board of Directors, which was May 19, 2008.
