Attached is an English translation of the summary of the letter dated December 19, 2003 filed by the Company with the *Bolsa de Comercio de Buenos Aires* and the *Comisión Nacional de Valores*.

By letter dated December 19, 2003, the Company reported that a holder of Company's Convertible Notes exercised its conversion right. Hence, the financial indebtedness of the Company shall be reduced in US\$ 25,000 and an increase of 45,871 ordinary shares face value pesos 1 (V\$N 1) each was made. The conversion was performed according to terms and conditions established in the prospectus of issuance at the conversion rate of 1.83486 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 220,646,441 to 220,692,312. On the other hand, the amount of registered Convertible Notes is US\$ 95,262,291.
