Attached is an English translation of the summary of the letter dated February 6, 2006 filed by the Company with the *Bolsa de Comercio de Buenos Aires* and the *Comisión Nacional de Valores*.

By letter dated February 6, 2006, the Company reported that Cresud S.A.C.I.F. y A., the main shareholder of the Company, exercised its conversion right. Hence, the financial indebtedness of the Company shall be reduced in US\$ 5,000,000 and an increase of 9,174,311 ordinary shares face value pesos 1 each was made. The conversion was performed according to terms and conditions established in the prospectus of issuance at the conversion rate of 1.83486 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 368,801,400 to 377,975,711. On the other hand, the amount of registered Convertible Notes is US\$ 51,980,997.
