QVT Financial LP ( QVT Financial ) is the investment manager for QVT Fund LP (the Fund ), which beneficially owns 836,600 shares of Common Stock, QVT Overseas Ltd., which beneficially owns 959,379 shares of Common Stock, and for QVT Associates LP, which beneficially owns 859,797 shares of Common Stock. QVT Financial is also the investment manager for a separate discretionary account managed for Deutsche Bank AG (the Separate Account ), which holds 597,624 shares of Common Stock. QVT Financial has the power to direct the vote and disposition of the Common Stock held by the Fund, QVT Overseas Ltd., QVT Associates LP and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 3,253,400 shares of Common Stock, consisting of the shares owned by the Fund, QVT Overseas Ltd. and QVT Associates LP and the shares held in the Separate Account.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial.

Each of QVT Financial and QVT Financial GP LLC disclaim beneficial ownership of the shares owned by the Fund, QVT Overseas Ltd. and QVT Associates LP and the shares held in the Separate Account.
