On March 21, 2013, SAP AG, a stock corporation organized under the laws of the Federal Republic of Germany ( "SAP" ), issued a press release (the "Press Release" ) announcing that the Supervisory Board of SAP has decided to follow the recommendation of the Executive Board to propose at the Annual General Meeting of Shareholders a dividend of 0.85 per share for the fiscal year 2012.
