Series D Mandatory Redeemable Preferred Stock (CUSIP 1846925#4) (the Series D MRP Shares and together with the Series C MRP Shares, the MRP Shares).

- 2. The date on which the securities are to be called or redeemed: The MRP Shares will be redeemed on February 24, 2016.
 - 3. The applicable provisions of the governing instrument pursuant to which the securities are to be called or redeemed:

The MRP Shares are being repurchased pursuant to Section 3(a)(ii) of the Articles Supplementary for the Series C MRP Shares and the Series D MRP Shares dated as of June 11, 2015.

4. The principal amount or number of shares to be called or redeemed and the basis upon which the securities to be called or redeemed are to be selected:

The Fund will redeem 152 Series C MRP Shares.

The Fund will redeem 420 Series D MRP Shares.

The number of MRP Shares to be redeemed will be allocated among all the MRP Shares outstanding in proportion, as nearly as practicable, to the respective unpaid principal amounts thereof.
