As previously announced, on August 15, 2017, Fifth Third Bancorp ( Fifth Third ) entered into an accelerated share repurchase transaction with Goldman Sachs & Co. ( Goldman ) pursuant to which Fifth Third would purchase approximately \$990 million of its outstanding common stock (the Repurchase ). Fifth Third is repurchasing the shares of its common stock as part of its 100 million share repurchase program previously announced in a current report on Form 8-K filed on March 16, 2016.

On December 14, 2017, Fifth Third was notified by Goldman that it had finished purchasing shares in connection with the Repurchase. A total of 31,540,480 shares were repurchased upon execution of the Repurchase agreement, and an additional 4,291,170 shares will have been repurchased upon completion of the agreement. The repurchase of the additional shares is expected to settle on Monday, December 18, 2017. In total, 35,831,650 shares will have been repurchased at an average price of \$28.0312 per share.

After the completion of the Repurchase, Fifth Third will have approximately 30.9 million shares of remaining repurchase authority under the aforementioned share repurchase program.

Goldman and certain of its affiliates have performed, and in the future may perform, various financial advisory and other services for Fifth Third and Fifth Third's affiliates for which they have received, and may in the future receive, customary fees and expenses.
