**Explanation of Responses:**

- (1) On May 2, 2007, NRG Energy, Inc. announced a 2-for-1 stock split, in the form of a stock dividend paid on May 31, 2007 to all holders of record of Common Stock on May 22, 2007, which resulted in Mr. Howell's ownership of 159,328 additional shares of common stock. The Company's Common Stock began trading on a split-adjusted basis on June 1, 2007. All share amounts referred to in this Form 4 reflect the stock split.
- (2) On August 1, 2005, Mr. Howell was issued 326,000 Restricted Stock Units ("RSU's") by NRG Energy, Inc. under NRG Energy, Inc.'s Long Term Incentive Plan (the "LTIP"). Each RSU is equivalent in value to one share of NRG's Common Stock, par value \$0.01. On August 1, 2007, 40,000 of the originally granted 326,000 RSUs vested. Pursuant to the LTIP, Mr. Howell elected to satisfy his tax withholding obligation upon the exchange of common stock for RSU's by surrendering a number of shares of common stock having a value on the date of the exchange equal to the tax withholding obligation. This form is being filed to reflect the surrender of 17,380 shares of common stock to satisfy the grantee's tax withholding obligation.
