(1) Each unit represents one share of Olin common stock. These phantom stock units were in a unitized stock fund, the Olin Stock Fund, held by The Dow Chemical Company (Dow) Employees' Savings Plan (CEOP), a tax conditioned plan. The phantom stock units were (2) acquired in transactions exempt under Rule 16b-3, including 6.28 units acquired since the date of the reporting person's last ownership report. On the transaction date, Dow liquidated the Olin Stock Fund, and replaced the investment with an investment unrelated to Olin. Conversion price is the per share price reported by Dow for plan level transactions in the CEOP.
