(1) On June 30, 2012 the Issuer issued a Promissory Note to Ms. McMorran totaling \$171,564.22. Under the terms of the Promissory Note, Ms. McMorran has the right to convert all or any part of the principal sum of the loan into common stock of the Issuer as well as a warrant agreement to purchase one share for every two shares acquired. The expiration date on the warrant is 3 years from the date of conversion.

(2) On June 30, 2012 the Issuer issued a Promissory Note to Ms. McMorran totaling \$3,989.58. Under the terms of the Promissory Note, Ms. McMorran has the right to convert all or any part of the principal sum of the loan into common stock of the Issuer as well as a warrant agreement to purchase one share for every two shares acquired. The expiration date on the warrant is 2 years from the date of conversion.
