- (1) Represents shares reacquired to satisfy tax withholding obligations in connection with the vesting of 29,000 shares of restricted stock granted to the Reporting Person on 3/2/09.
- (2) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 9/1/10 and 1/48th per month thereafter.
- (3) Each restricted stock unit represents a contingent right to receive one share of eBay's common stock.

- (8) Options become exercisable as to 25% on 9/2/09 and 1/48th monthly thereafter.
- (9) The reporting person received restricted stock units of 75,000 shares subject to a four-year vesting schedule, vesting 25% on 10/10/09 and 25% annually thereafter.
