- (1) Options become exercisable as to 25% on 4/28/09 and 1/48th monthly thereafter.
- (2) On September 11, 2009, the issuer canceled, pursuant to the issuer's option exchange program, an option granted to the reporting person on May 9, 2008. In exchange for the option, the reporting person received 12,500 restricted stock units. *See* also footnotes 4 and 7.
