- (2) The Reporting Person directly owns 0 shares of the Common Stock. TM and TOA directly own 0 shares of Common Stock. TP directly owns 11,545,751 shares of Common Stock. TOF directly owns 6,465,230 shares of Common Stock. The separately managed accounts directly own 405,895 shares of Common Stock. All of the foregoing shares of Common Stock may be deemed to be beneficially owned by the Reporting Person.
