Each of Partners, BVF Inc. and Mr. Lampert disclaims beneficial ownership of the shares of Common Stock beneficially owned by BVF, BVF2, Trading Fund OS, and the Partners Management Accounts, and the filing of this statement shall not be construed as an admission that any such person or entity is the beneficial owner of any such securities.

The following percentages are based on 14,401,582 shares of Common Stock outstanding as of March 4, 2016, as disclosed in the Issuer's Annual Report filed on Form 10-K with the Securities and Exchange Commission on March 8, 2016.
